Re: Canadian Dental Care Plan, Pharmacare, Safe Long-term Care Act

Dear Minister Michel:

This letter is to congratulate you on your new role as Minister of Health and inform you of the Council of Senior Citizens' Organizations of BC's (COSCO BC) fervent support for federal health care initiatives that support the health and wellbeing of all Canadians.

COSCO BC is a non-profit, non-partisan, independent, volunteer driven organization that has promoted the well-being of seniors since 1950, representing over 80,000 members from 70 affiliated seniors-led organizations across BC. COSCO advocates for policies that allow seniors to remain active, independent, and engaged in society. We keep our members informed of the plan and are vigilant in counteracting disinformation spread by others through our discussions at meetings, website and articles in our quarterly *COSCO News*.

We write to let you know that we celebrated the implementation of the Canada Dental Care Plan (CDCP) knowing that many seniors would be able to access dental care and have improved oral health. We also celebrated the passing of the Pharmacare Act, the first phase of national and universal pharmacare that will provide universal access to diabetes medications and contraception. We were very pleased to learn that Prime Minister Mark Carney recently reiterated his support for this Act and reassured Canadians that Health Canada would continue to actively negotiate agreements with provinces that have not already signed on.

We are hopeful that the current federal government will continue to maintain and support improvement in these important programs. For example, regarding the CDCP there is a need for alternative processes to remove the annual requirement to re-establish eligibility. Furthermore, we would suggest that the impact of the program criteria that disqualifies Canadians who have access to private insurance must be reviewed through the lens of equity. Not all Canadians with apparent access

to private dental insurance through employer/pension plans are able to access dental care due to unaffordable premiums and/or co-payments or limits on life-time coverage. Also the CDCP income thresholds used to determine eligibility and co-payments should be indexed annually in order to keep pace with inflation.

In closing, we express our support for the government's commitment to improving the quality, safety, equity, and availability of long-term care services through their support for the new national standards and the extensive national consultation that was conducted in 2023 to inform the development of the Safe Long-term Care Act. We note that a goal was set to table legislation in 2024, and we would urge the government to follow through on this intention.

Thank you for your attention to these matters, which are so important to the quality of life and well-being of older Canadians.
